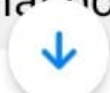

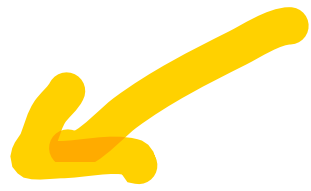



Attended the Licking County Commissioner meeting today to discuss Solar Exclusionary Zones for Etna Township.


The commissioners confirmed that contrary to what our administrator had repeatedly stated (as recently as our Comprehensive Plan Meeting and last trustee meeting), they WILL address a request from our board should we ask to create an exclusionary zone (prohibit) large scale solar farms in our township.

The administrator stated... why would we do anything if they won't take it up? This is false as again confirmed by the commissioners themselves and previously being quoted in the Newark Advocate.

We can ask the commissioners to create an exclusionary zone for large scale solar in our township. At that point, they would have public hearings and then decide to create the zone or not. Many other counties have granted townships this exclusionary zone status.

Like the pond issue, I don't understand why proper due diligence and fact gathering isn't done before claims/actions are made which are not true or proper.



McKee and Johnson just refuse to do anything properly.

They forced a lease of land with a contract with was deficient per our prosecutor. Used outside attorneys to draw up the contract at an expense to the township when the prosecutor is our free attorney. Leased the land for well below the market rate (\$125 per acre vs \$170-180).

There are serious questions about last year's use of the land, where was that lease? Where is that money? McKee claims it wasn't farmed but there are documents stating otherwise. And if it wasn't farmed, why did McKee drop the ball and we kiss that revenue?

Again McKee and the administrator refused to work with the full board in a cooperative agenda. Nothing has changed with the hiring of the administrator, except we are now paying \$62.50 per hour for the same improper administration.
