Etna Township Trustees

The Etna Township Board of Trustees met on June 15, 2004 in the Etna Township Hall to hold a regular meeting. The meeting was called to order at 7:00 p.m. by President Burkholder and the pledge of allegiance was recited.

Roll call showed Mr. George, Mr. Burkholder and the clerk present. Mrs. Siddens was absent.

ADOPTION OF THE AGENDA

Mr. George moved to adopt the agenda. Burkholder seconded.

Roll Call: George, yes; Burkholder, yes.

ADOPTION OF THE MINUTES

Mr. George moved to adopt the June 1, 2004 meeting minutes. Burkholder seconded. Roll Call: George, yes; Burkholder, yes.

PUBLIC COMMENTS

Roger Ailiff, 7297 Palmer Road, registered a complaint about water runoff onto his and his neighbor's property. The problem has become progressively worse with the construction of new homes in the area. Mr. George suggested some possible solutions and will contact the county engineer's office.

Dennis Jackson, 15345 Palmer Road, asked to be notified when the meeting with Reynoldsburg concerning Taylor Road is scheduled.

Neil Ingle expressed serious concern that the 1/5/04 audio and video tapes, which he had requested copies of, can not be found. He will conduct a search with the secretary the following morning.

Tom Dixon, 8467 Hazelton-Etna Road, said he had asked Dallas Maynard to visit his property, which abuts Cameron Chase, when there was high water. The high water is a common occurrence in the spring and not a 100 year floodplain deal. Water was going everywhere. Mr. Dixon said "what they had dug out, the width of it, was probably 40' wide and bypassed when a pipe that comes down through against his property along the west side of the project (Cumberland Chase)." There are three or four manholes. "The water was coming out of the second manhole to the north with everything coming up running down along the side of the property and cutting through behind their piles of dirt. Their piles of dirt really didn't bother anything because it washed through on the north side of it and that part was probably another 10' or better wide and over a foot or so in depth. The part they brought the road on down, they had stopped back early from the ditch so there is a lot more bypass water that has to go around or go somewhere where it is going to come up on my property. The electric boxes and telephone stuff crossed in the floodplain was probably 8 inches or 10 inches deep in the water." If this situation can not be remedied, then the liability will come back to Etna Township or the county. He expects property damage will happen against this project. Photos were presented.

President Burkholder said two of the Licking County Commissioners were present at the meeting when the final plat of Cameron Chase was approved. Concerns regarding the green space, the number of lots and the reconfiguration had been expressed at that meeting. Mr. Dixon had also expressed his concern on the flow of the storm water.

Resolution 04-06-15-01: President Burkholder moved that Mr. Dixon's comments, in detail, be reflected in the minutes and a copy of the minutes be forwarded to the Licking County Commissioners, Licking County Planning Commission and the Licking County Soil and Water expressing the trustee's concerns as well, relative to the management of storm water on that project. George seconded.

Discussion: Mr. Dixon added that it was a flat 3" rain in the area when the pictures were taken and high water occurs several times every year. The new road will be level or higher than his property and the water will flow to his property. This is going to be a serious problem, the

Dear Mr. George:

I am responding in writing to the questions you posed to me over the telephone on June 3, 2004. I am also sending a copy of this letter to the other Etna Trustees and to the Clerk. It is my intent that this letter be made a part of the public record of Etna Township.

The Ohio Attorney General has written two opinions stating that the failure of a member of a board of township trustees to regularly attend meetings and to properly discharge the trustee's duties does not result in a vacancy of such office, but may be ground for removal of such township officer under R.C. 3.07 through R.C. 3.10. I see no reason to question these opinions.

I am including R.C. 3.07 through R.C. 3.10 with this letter. As you can see, the process for removal is initiated by a complaint signed by a specified number of qualified electors. The township board, in its official capacity, has no authority to start the proceedings.

You also expressed to me your dissatisfaction that my office has not "solved" the South Street right-of-way problem. In reviewing the file, I see that we notified you that the Board of County Commissioners would not use its eminent domain powers to extend South Street. In addition, we asked you if you wanted my office to try to negotiate with the current property owners. In fact, an offer was made to the effect that a representative of my office would meet with you to discuss this matter. To date, we have not heard from you as to what you want done. In fact, we have even "heard" that a majority of the Etna trustees is no longer interested in building on the lot off South Street

Quite frankly, I have no idea which way to proceed. Once the board has decided then let me know.

The recommendation was to be approved by all members of the board before it was presented to the trustees. The motion as stated was illegal. Mr. Bravard would not allow a special meeting, that was requested by other members, to be held for a correct motion to be passed.

President Burkholder said for the record, he contacted Mr. Bravard and told him that he (Bravard) could not make the recommendation as stated. Burkholder said Bravard replied that it was always the practice in the past that when a motion failed, then just the opposite is the recommendation. Burkholder expressed grave concerns about Bravard's actions. Previously there were problems with the removal of R-3 and PUD's regarding recommendations not being signed.

Mr. George said he was not opposed to having a public hearing for Mr. Bravard; either Bravard resigns or he does his job. George feels the chairman of the zoning commission and BZA are acting unprofessionally and doing things that are not within their power.

President Burkholder said there were many irregularities previously and this was not an accident. He feels that there has been a deliberate attempt by a few zoning commission members to derail the removal of the PUD and R-3 zoning. This effort may also extend to the county because it took over six months for LCPC to release legal opinions from the county prosecutor regarding the PUD. Apparently the county and a few zoning commission members are not listening to what the citizens of this community want to see. Burkholder suggested to wait and see how the zoning commission handled the situation. Burkholder would not be opposed if the board decided to send Mr. Bravard a letter of concern, a letter of reprimand or brief him in on a public hearing. President Burkholder said he has not had a reply to the letter sent to Mr. Cox regarding the way the recent BZA hearing was conducted.
